Klauer Manufacturing will upon notification and verification of any defect, at its sole option, either repair, refinish or replace that portion of the Product which has been found defective. If Klauer Manufacturing is unable to make replacement, and repair is not commercially practicable or cannot be performed within a reasonable period of time, Klauer Manufacturing may elect to refund to the Owner the initial installed cost of the Product found to be defective.

Duration of Warranty

The Limited Lifetime Warranty (Warranty) shall be effective upon registration as set forth below and shall remain in effect for as long as the owner of the property to which the Products were originally applied (Original Property Owner) continues to live and to own the property. In the event there is more than one Original Property Owner, this Warranty will remain in effect as long as one of the Original Property Owners is living and owns an interest in the property. However, Klauer Manufacturing has applied to the United States Seamless® Platinum Series™, Mountain Cedar® and Northwoods™ Seamless Steel Siding and Steel Accessories and United States Seamless® Platinum Series™ Steel Shake and Shingle Accent Siding (Product) coatings designed to minimize fading and chalking.

Klauer Manufacturing warrants that the Platinum Series™, Mountain Cedar® and Northwoods™ Seamless Steel Siding and Steel Accessories and United States Seamless® Platinum Series™ Steel Shake and Shigde Accent Siding will not fade or change color in excess of five (5) Delta E Units for a period of forty (40) years from the date of original installation and seven (7) Delta E units thereafter, as measured using the procedure of ASTM D-2244, comparing an unexposed panel to the exposed panel after removal of surface soils and oxidation.

Additionally, Klauer Manufacturing warrants that the Platinum Series™, Mountain Cedar® and Northwoods™ Seamless Steel Siding and Steel Accessories and United States Seamless® Platinum Series™ Steel Shake and Shingle Accent Siding will not chalk in excess of ASTM D-659 numerical rating of eight (8) for a period of forty (40) years from the date of original installation and six (6) thereafter.

This Warranty is transferable by following the transfer procedures set out below from the Original Property Owner to a subsequent owner of the property and by any subsequent owner of the property to another subsequent owner of the property (see warranty transfer).

If the Products are severely damaged by hail during the Warranty period, and to the extent that such damage is not otherwise covered by insurance coverage, such as homeowner's insurance, excluding deductables, Klauer Manufacturing will, upon notification and validation of the claim, subject to the proration provisions set forth below, either repair or replace only those Products severely damaged by hail or, if Klauer Manufacturing is unable to make replacement and repair is not commercially practicable or cannot be performed within a reasonable period of time, refund an amount in cash equivalent to its prorated share of the original purchase price (materials only) of the hail-damaged Products. Mandatory Registration

The obligations of Klauer Manufacturing under this Limited Lifetime Warranty shall become effective only if the original property owner or owners, fully and accurately complete, sign and mail the attached registration card by certified mail to United States Seamless, Inc., Warranty Registration Dept., 474 45th St S, Fargo ND 58103, within thirty (30) days of the completed installation.

If the Warranty is not timely registered, then Klauer Manufacturing shall have no obligation under this Limited Lifetime Warranty. By properly registering this Warranty you are automatically registered for all three Limited Lifetime Warranties covered on pages one, two and three of this Warranty.

Warranty Transfer and Proration

This Limited Lifetime Warranty may be transferred by the original property owner to subsequent owners of the property, upon payment of a \$300 transfer fee, provided that, the original property owner (or previously registered transferee) sends, by certified mail, to United States Seamless, Inc., Warranty Transfer Dept., 474 45th St S, Fargo ND 58103, a notification of the transfer of the property, the \$300 transfer fee and the date of transfer signed by the original owner (or previously registered transferee) and the new owner within thirty (30) days following transfer of title to the property. In the event United States Seamless, Inc. does not receive a timely transfer of the Limited Lifetime Warranty as set forth above, then the Warranty to the original owner shall expire as of the date of transfer of the legal title to a new owner.

As long as one of the original owners who has signed the original Warranty Registration Card (or previously regis tered transferee remains a co-owner of the property, then transfer of this Warranty is not required. If Owner gives proper notification of transfer all three Limited Lifetime Warranties covered on pages one, two and three of this warranty will be transferred.

Claims Procedure

Any claims for defects under this Warranty must be submitted by certified mail to United States Seamless®, Inc., Warranty Claims Dept., 474 45th St S, Fargo ND 58103 within the Warranty period, must include a \$100 service and inspection fee for each incident, and shall be made within thirty (30) days after discovery of the claimed defect. The claim should describe the claimed defect and the date the defect was discovered. It should also reference the Warranty registration number (if available) if Warranty registration number is not available, then the claim should reference the date of original installation, and should include the name, address and phone number of the owner. United States Seamless® will provide notification of the specific information and physical evidence required to process your claim. ANY REPAIR OF THE PRODUCTS UNDERTAKEN WITHOUT PRIOR WRITTEN AUTHORIZATION FROM KLAUER MANUFACTURING WILL VOID THIS WARRANTY.

CARE AND MAINTENANCE INSTRUCTIONS

United States Seamless® Platinum Series™, Mountain Cedar® and Northwoods™ Seamless Steel Siding and Steel Accessories and United States Seamless® Platinum Series™ Steel Shake and Shingle Accent Siding provide the rich look of traditional siding without the upkeep. The Platinum Series™ finish is highly resistant to UV rays and most man-made pollutants. In most cases, normal rainfall is sufficient to keep it clean. But if your United States Seamless® Platinum Series™ Mountain Cedar® and Northwoods™ Seamless Steel Siding and Steel Accessories and United States Seamless® Platinum Series™ Steel Shake and Shingle Accent Siding should need cleaning, the following procedures are recommended. Particular attention should be given to areas under eaves, porches, awnings and other overhangs that have limited exposure to the natural washing effect of rainfall.

- Moderate Atmospheric Dirt -An occasional washing with clear water using a garden hose and softbristled brush is recommended (a long-handled, car washing brush is ideal for this purpose).
- 2. Heavy Industrial Atmospheric Dirt Wash in the manner indicated above, but use the following solution:
- a. 1/3 cup detergent (Tide®, for example)
- b. 2/3 cup trisodium phosphate (Soilax®, for example)
- c. 1 gallon water
- 3. Mildew Accumulation -Mildew can collect on surfaces of all types of building products and is often evident on surfaces that have not been properly cared for and maintained. Normally, mildew will appear as black spots. Mildew is easy to remove by using the basic cleaning solution above with the addition of sodium hypochlorite as follows:
- a. 1/3 cup detergent (Tide®, for example)
- b. 2/3 cup trisodium phosphate (Soilax®, for example)
- c. 1 quart sodium hypochlorite 5% solution (Clorox®, for example)
- d. 3 quarts water
- 4. Caulking Compounds, Tar and Similar Substances -Use mineral spirits in reasonable amounts and apply directly to the foreign substance. Immediately after cleaning, rinse the area thoroughly with water.

CAUTION: Do not exceed the recommended concentrations of cleaners. To do so can cause damage to the Product's surface. Avoid skin and eye contact with the solution, and in all cases follow manufacturer's instructions for the use of cleaning compounds and solutions. Avoid use of abrasive-type cleaners and strong solvents. Test any cleaner on an inconspicuous area before applying to major areas. To minimize streaking, always clean from the bottom to the top and follow with a rinsing of clean water. Excessive scrubbing is unnecessary and can be harmful to the products.

PAINTING: As provided in the warranty, painting will void the warranty unless authorized in writing by Klauer Manufacturing.

Any minor product adjustments should be discussed with your authorized United States Seamless® franchisee who performed the work. These adjustments can best be made by your authorized United States Seamless® franchisee, since he or she is most familiar with your particular installation.
